Furthermore, I acknowledge that the **50 Hour Film Contest**, or its assigns, may shoot behind the scenes "making of" the **50 Hour Film Contest** footage, for use in a motion picture, and I hereby irrevocably grant to the **50 Hour Film Contest**, its licensees, agents, successors and assigns, the right, but not the obligation, in perpetuity throughout the world and in all media, now or hereafter known, to use (in any manner it deems appropriate, and without limitation) in and in connection with the motion picture, by whatever means exhibited, advertised or exploited: my appearance in the motion picture, still photographs of me, recordings of my voice taken or made of me by it, any music sung or played by me, and my actual or fictitious name.
